



THE PROCESS TO WITHDRAW YOUR SIGNATURE

(per RSMO 116.110)

1. **Create a Sworn Statement:** Draft a written statement that includes the following information:
 - The name of the petition you signed
 - The name you used when signing the petition
 - Your address
 - Your county of residence

2. **Swear Under Oath:** The statement must be sworn under oath. You can do this by visiting a notary public.
3. **Submit to the Secretary of State:** Send the sworn statement to the Missouri Secretary of State. You can mail it or deliver it in person. Include your contact information so they can verify your identity.

4. **Timing:** You must submit the withdrawal before the petition is filed with the SOS. Once the petition is filed, your signature cannot be removed.

10 REASONS TO **DECLINE** TO SIGN

Pro-Abortion Petitions

1 **Parental Consent laws will be eliminated**

Abortions could be performed on pregnant minors without notice to or consent from the minor's parents.

2 **Late-term dismemberment abortions on demand**

Abortion will be allowed from conception to live birth, including brutal late-term dismemberment abortions.

3 **Abortion - all 9 months**

Abortions will be allowed for "physical or mental health" reasons all 9 months - from conception to live birth.

4 **Health & Safety standards eliminated**

Missouri law requires health and safety standards for abortion clinics. These would be eliminated if this amendment passes, and would allow anyone to perform abortions without a healthcare license.

5 **MO's 52+ pro-life laws will be eliminated**

Our pro-life laws will be nullified by enshrining a "right" to abortion in our Missouri Constitution.

6 **Women lose ability to sue for malpractice**

A woman's ability to seek criminal prosecution/civil penalty of any person who performs/assists/provides support to induce/seek/obtain an abortion will be eliminated.

7 **PRCs forced to refer for abortion**

Pregnancy Resource Centers will be forced to refer for abortion.

8 **Ultrasounds eliminated**

Abortion clinics will no longer be required to offer or show a mother her baby's ultrasound image.

9 **Significant \$ Loss to MO**

Missouri could suffer a significant loss to state and local revenue if this language is enshrined in the Missouri Constitution.

10 **Taxpayer-funded abortion**

Your legislator will be unable to refuse to appropriate funds to abortion providers.
