

Did you know there have been over 81 medical emergencies at the Planned Parenthood in St Louis since 2009. These emergencies, requiring ambulance transport, have taken place when most, if not all, of our health and safety regulations were active and enforced.

Now imagine what will happen when abortion clinics start opening across the state of Missouri and all our health and safety regulations are thrown out by the courts based on the pro-abortion language now in the Missouri Constitution that allows for abortion all 9 months of pregnancy with no accountability.

6. Build your local volunteers for door-knocking and phone-banking.
7. Find financial sponsors for newspaper ads, billboards. Work with MRL on the ads.
8. Help with donors to MRL for this campaign.
9. Work polling locations on election day.
10. Begin praying now.

- Allow abortions for rape and incest (under twelve-weeks' gestation), emergencies, and fetal anomalies;
- Allow legislation regulating abortion;
- Ensure parental consent for minors' abortions;
- Prohibit gender transition procedures for minors?

A **"YES vote on the 2026 Amendment 3"** will remove abortion on demand all nine months of pregnancy from our Missouri Constitution and allow our legislators to pass legislation to protect women, children and pre-born babies again.

A **"NO vote on the 2026 Amendment 3"** keeps abortion on demand all 9 months of pregnancy in our Missouri Constitution and ties the hands of our duly elected officials to pass pro-life legislation.
